MARINA ADVISORY NO. 50 - 2020 Series of 2020.

TO : ALL SEAFARERS, MANNING/SHIPPING COMPANIES, SHIP

OWNERS AND OPERATORS AND ALL CONCERNED

SUBJECT: EXTENSION OF THE VALIDITY OF STCW CERTIFICATES

It is recalled that the Maritime Industry Authority (MARINA) had earlier issued MARINA Advisory No. 2020-44 dated 11 June 2020 which provides that all STCW certificates of Filipino seafarers serving onboard ships that have expired or are expiring between 01 June 2020 to 30 June 2020 are hereby automatically extended for a period of six (6) months from the date of expiry without the need to file for an application at the MARINA.

After the lapse of this period, the (MARINA) has been receiving numerous appeals from the maritime industry stakeholders seeking further extension of STCW certificates of their Filipino crew. They conveyed that their crew could not be safely repatriated or disembarked due to difficulty in the implementation of crew change, brought about by the port and travel restriction imposed due to the corona virus disease (COVID-19) pandemic.

In view of the foregoing and taking a pragmatic and practical approach with regard to the extension of the validity of seafarer's certificates as emphasized by the international Maritime Organization (IMO) in its Circular Letter No. 4204/Add.5/Rev.1 dated 02 April 2020, all STCW certificates of Filipino seafarers currently serving onboard ships which have expired or are expiring during the period 01 July 2020 to 31 July 2020 shall be extended for a period of six (6) months from the date of expiry without the need to file for an application at the MARINA.

All concerned manning/crewing agencies and shipping companies are hereby directed to immediately submit to the MARINA the list of their crewmember/s whose validity of STCW certificate/s have been extended pursuant to this Advisory. An electronic copy of the said information shall be submitted via e-mail at certificate extension@mail.narina.gov.ph following the template attached herein as Annex "A".

This Advisory shall take effect immediately.
