Effective 12 February 2019, Tuesday, all expedite transactions at MARINA Central Office concerning issuance of seafarer's documents relating to STCW shall be facilitated by accredited Liaison Officers only.

No individual expedite applications by the seafarers themselves shall be entertained.

Liaison Officers are advised to bring the original documents of the seafarers and present to the Evaluators.

In addition, to support the expedite application to be filed by accredited Liaison Officers, the following documents must likewise be submitted:

- Letter request for expedite processing from the company using the template in Annex A. The letter must bear the official logo of the company and duly signed by its authorized official/s; and
- 2. Employment Contract of the concerned seafarer/s duly approved by the Philippine Overseas Employment Administration (POEA).

Concerned shipping companies or manning/crewing agencies and accredited Liaison Officers shall ensure the authenticity and completeness of the documents to be presented/submitted to MARINA. Incomplete documentary requirements shall not be accepted/processed.

For guidance and strict compliance.

This Advisory shall take effect immediately.
