TO : ALL SEAFARERS, EXISTING ASSESSMENT CENTERS FOR RATINGS, SHIP OWNERS, MANNING AGENCIES, OTHER ENTITIES AND INDIVIDUALS CONCERNED

SUBJECT : AMENDMENTS ON THE PROPER CITATIONS INDICATED ON STCW CERTIFICATES

Notice is hereby given that pursuant to Republic Act No. 10635 and its Implementing Rules and Regulations (IRR), the 1978 Intentional Convention on Standards of Training, Certification and Watchkeeping (STCW 78) for Seafarers, as amended, proper citations of STCW Regulations reflected on Certificate of Competency (COC), Certificate of Endorsement (COE), Certificate of Proficiency (COP) issued by this Authority shall be the corresponding main **REGULATIONS** equivalent to the training certificate of the holder. The specific type of training shall be indicated in the Function Column of the subject COC/COE and COP, for example :




